Directions to Skyview

From within Sussex County:

We are located at 226 Lafayette Road, Sparta, New Jersey. Lafayette Road is Route 181. SkyView is located on the southbound side of Route 181, 1/2 mile south of the intersection of Route 181 and Route 15 and 1 mile north of the intersection of Route 181 and Newton-Sparta Road (Route 517).

From New York Metro Area:

Interstate 80 West to Exit 34B for Route 15 North. Take Route 15 North for 10 miles to the exit for Route 517. Make a left onto Route 517 South and proceed 1/2 mile to the second traffic light. Make a right onto Lafayette Road (Route 181). Proceed 1 mile and make a left onto SkyView Drive. Make the first right into the golf club parking lot.

From South Jersey:

From southcentral or southwest New Jersey take Interstate 287 North to Interstate 80 West. Follow directions above.

From southeastern New Jersey:

Take the Garden State Parkway north to Interstate 280 West. Take I-280 West to I-80 West and follow directions above.

From Eastern Pennsylvania:

Take Interstate 80 East to Exit 34 for Route 15 North. Follow directions above.
