A Regular Meeting of the Mayor and Council of the Borough of Hasbrouck Heights was held on Tuesday, June 22, 2010 at 8:08 p.m. at Borough Hall, 320 Boulevard, Hasbrouck Heights, New Jersey.

**REPORTS:**

**POLICE:** Under Police, Commissioner DiPisa gave the following report: due to the quick thinking of Patrolman Joseph Armeli three perpetrators who committed multiple robberies were apprehended. He recognized a license plate which appeared on SPEN radio, connected with attempted robberies in East Rutherford and Hasbrouck Heights. He gave chase and as the vehicle was going west on Passaic Avenue toward Lodi, with backup support, the three were apprehended and stolen merchandise recovered. Councilman DiPisa also commended Jarred Cooke who is doing a great job on the Boulevard and Dominick D'Amico who graduated the Police Academy in June. He said that on June 12 a call was received reporting a burglary in progress. Sgt. Sisto and Det. Colaneri Jr. responded and located the actor outside the residence. The actor was charged with two counts of burglary and theft. The high school junior class had a chance to see the dangers of drinking and driving by using golf carts and the fatal vision goggles which give the illusion of being under the influence. **(cont'd):** talked about texting and using cell phones while driving. Chief Colaneri, Capt. DeLorenzo and Sgt. Rinke ran this very valuable event. The Department participated in the Law Enforcement Torch Run for Special Olympics, with \$25,000 raised locally for these athletes. Chief Colaneri, Honor Guard members, Sgt. Rinke, Det. Colaneri Jr. And Det. Adamo attended the opening ceremony at the College of New Jersey.

**RECREATION & PARKS:** Under Parks, she reported new certified playground mulch has been distributed at Woodland Park, Central Avenue Park, and Miers Park playground areas. Frequently more mulch must be put down in the areas where the swings are located. At Woodland Park, the irrigation system was checked and repaired as some sprinkler heads were not operating properly. All parks have had grass seed spread and the DPW continues to apply seed as needed. Woodland Park has been very active with eleven picnics so far this season from schools activities to events held by residents. Under Recreation, Commissioner Buckman reported the Recreation Center is open on Friday and Saturday evenings from 7pm-10 pm and available for Hasbrouck Heights children in grades 6<sup>th</sup>-8<sup>th</sup>, and will be closing on June 25 for the summer. Recreation Softball had a great season with all 8 teams making the playoffs, Coach DeLorenzo's team finished 2<sup>nd</sup> in the minor division and had an undefeated regular season. Coach Bothe's team make it to the semi final round of the minor division playoffs, Coach Partyka's team also made it to the semi finals in the Junior division and Coach Gasparino's team finished with a 7-3 record. Recreation will also be hosting 2 UGAL teams for competitive play during the summer. Recreation Camp will open June 28 for all Hasbrouck Heights Boys and Girls six years old (before June 25, 2010). Adult programs and senior programs are ongoing. On July 15, the Senior Picnic will be held in the Senior Center. She congratulated Rob Brady who was recently named Coach of the Year in the Bergen Record for the boy's track program. As liaison to the Library, she reported that for the month of May there was an overall 7% increase in library circulation compared to last year. There were 47 new registrants, with overall total 7,599 card holders. The staff discharged 8,022 items, 10,955 patrons, reference questions 264. Summer programs include "Make a Splash at the Library" reading program, teen program "Make Waves at the Library", there are two six-week programs for students entering 7th-9th and 10th-12th grades. A teen reading contest and monopoly tournament is also planned. An adult reading program will also be sponsored entitled "Water your Mind - Read."

**FIRE:** Under Fire, Commissioner Gonzalez read the following activity report submitted by EMS Coordinator Elizabeth Waring: May 15 through June 15 there were 21 fire calls, 16 non-emergency calls and 148 EMS calls of that mutual aid calls were made as follows: Lodi 2, Mahwah 1, Teterboro 14, Paramus 3, Little Ferry 1. All the apparatus is back in service. He thanked Joel and Andrew DeMicco of the Heights Bar and Grill for their generous donation to the Fire Department. Under Recycling, he reported that on Saturday, June 5, the third annual paper shredding event was held in the Central Avenue Parking lot and a total of 2,700 lbs. of paper was shredded. On July 3, the

**FINANCE & PUBLIC FACILITIES:** Under Public Facilities, Commissioner Link reported that upon re-inspection by the New Jersey Department of Health, Right-To-Know Program (R-T-K), the Borough passed all regulations as set forth by the New Jersey Department of Environmental Protection. The following Borough facilities were inspected: Municipal Building, Library, Public Safety Building (Police and Fire), DPW, Masonic Learning Center @ 301 Division, and Franklin and Woodside Pump Stations. The Department of Public Works completed repairs at the Police Pistol Range which is located behind the DPW facility. The list of the repairs is as follows: 1. Replace retaining wall in front of target areas. 2. Replace electrical system from lights in target area. 3. Repaired roof on Police Trailer. The schedule of meetings was as follows: Community Room 13; Caucus Room 6; Council Chambers 5; Senior Center 2 (not including senior activities). Under Finance, Commissioner Link reported the Current Fund cash balance at May 31, 2010 was \$2,546,074.37 and at April 30, 2010 was \$314,419.28 which represents an increase of \$2,231,655.09. The entire balance was invested and earning approximately 0.70%. Cash receipts for the month of May totaled \$6,133,077.04 of which \$5,947,709.83 was for current taxes, \$36,410.82 was for delinquent taxes, \$17,837.56 was Grants Received and \$131,118.83 was miscellaneous revenues. Cash disbursements for the month of May totaled \$3,901,421.95 of which \$1,785,879.00 was for local school taxes, \$932,850.00 was for County taxes, \$646,353.34 was for salaries and \$536,339.61 was for other expenses. The 2010 municipal budget was introduced at the April 13, 2010 and public hearing on May 11, 2010. The adopted budget was transmitted to the Division of Local Government Services as required by statute. Tax bills cannot be generated until the County Budget is adopted and approved by the Division. As of today the Division has not certified the tax levies required to generate final tax bills. The Chief Financial Officer has been working with the Tax Collector to determine if estimated tax bills would be required this year and tonight's agenda included a resolution authorizing them. The estimated bills will be maintained within the next two weeks. She said it is important to note that the total 2010 taxes will not be equal to the third quarter estimated tax bill multiplied by four, this would overstate the total 2010 taxes.

**STREETS, SANITATION & TRANSPORTATION:** Commissioner Dingertopadre reported the DPW has completed the cleaning of the sanitary sewer system located on the Route 17 north and south bound lanes. The Department of Transportation was noted by Bill Spindler DPW and licensed Sewer Operator as to highway lane closures and the maintenance was performed over a four day period. During the course of operation the DPW found debris left behind from an improvement project that the DOT undertook in that area. The debris was found in the bottom of a manhole located in the proximity of KFC and Route 17 South. He met with Mr. Kronyak and Borough Engineer Job to document the findings and a report from Mr. Job will follow.

**HEALTH, SOCIAL SERVICES AND LAND USE:** Under Health, Commissioner Lipari began his report: Annual Dog Census: The Hasbrouck Heights Board of Health announces that the Annual Dog Census will begin on Monday, June 28, 2010. School Crossing Guards will be making a door-to-door canvas. Every home, apartment and commercial establishment in the borough will be visited. The Health Department asks residents who may not be home when the crossing guards visit to please leave a copy of their current (2010) license in a visible place for the crossing guards to see. If you have any questions or doubts about the person visiting your home, please call Laura French at 201-288-1636 or the Police Dept at 201-288-1000 immediately. The guards will be wearing their uniforms and will have Borough identification. They will be conducting the census between the hours of 4:30 to 8:00 pm Monday thru Friday. Blood Screening Program: The Board of Health's first Annual Blood Screening Program was a big success and offered an excellent opportunity for people to check on their body's internal wellness. Services included Chemistry Profile, PSA test and a Vitamin D25. The program will continue annually. Senior Wellness Luncheon will be held on Thursday, August 19<sup>th</sup> in the Senior Center 11:00 am to 2:00 pm. Care-One at Wellington of Hackensack will be providing the complimentary lunch. The speaker during the luncheon will be a representative from H.A.R.P. Family and Friends CPR: The Hasbrouck Heights Board of Health in conjunction with the Health Awareness Regional Program of Hackensack University Medical Center is offering a Free Family & Friends CPR course on Wednesday, July 14 from 6:30 to 9:30 pm at the Borough Hall. The class will help families learn specific CPR skills to an adult/child and infant. You will learn the signs of choking, and how to help a choking victim. You will also learn how to phone 911 and answer a dispatcher's questions. Pre-registration is required, and the cost of CPR manual is \$7.50. For further information and to register please call Laura French at 201-288-1636. Under Land Use, Commissioner Lipari reported total fees collected totaled \$16,325. Residents were reminded to advise the town when residents are working without a yellow permit card in their window. There were 102 UCC inspections during the month with 87 passing on the first inspection. The Property Maintenance official made 26 initial inspections, and went back to 38 re-inspections. He issued 12 warning notices and three summonses. Under Social Services, he reported during the month of June the pantry helped over 67 residents in need. He thanked the generous volunteers who help stock and supervise the pantry, and donors: Josephine McClean, Kathy Van Jura, First Reformed Church, Karla Kling, Dinae Fontaccione, St. John the Divine, Connie Margagliano, Masonic Lodge, Steven Reyngoudt, Arlene Carreau, Karen McDowell, HH Middle School, Ethel Ball, Kingsley Family, Phylliss Burman, Tom White, Erica Albright, Women of the First United Methodist Church, Joan Turner, John & Joan Mion, Joe Zahn and Ron Ellis.

**June 1<sup>st</sup>, Tuesday, 11:30 a.m.** attended the Finance Committee Meeting with Chair Pam Link and Borough Administrator Mike Kronyak. Information was given to us concerning Red Light Cameras for the lights on Route 17 North and South. The Police Traffic Bureau is reviewing same.

**June 2, 7:30 p.m., Wednesday**, Attended the Planning Board Meeting at which time two new members were named: Anthony Niosi and Andrew Heisey. They also serve on the Zoning Board. Chair Hank Dobbelaar asked for a motion to accept with regret the resignation of Vice Chair Gilbert Hunt with thanks for his many years of service. It was so accepted. Mr. Hunt has moved out of town thus his resignation.

**Thursday, 8:30 a.m. The Business Community Committee** met to review the success of the May 16<sup>th</sup> Street Fair and to take a formal photo. I thanked all of them for their work over the past year and we all thanked Cliffhanger Productions for a job well done. The Committee agreed to again support the hiring of Cliffhangar Productions for next year's Street Fair to be held again in May. It recommends that the Council approve the contract at its July meeting and give Cliff Witmeyer the opportunity to put together an even better campaign and allow him time to gather more sponsors and vendors.

**9:30 a.m.** Attended the State's School Board Trustees meeting held in our Library. Budget matters and areas of concern to those present were discussed and questions answered. Also in attendance were Hasbrouck Heights Board President Lisa Traina, Board Trustee Dr. Burnett Eglow and our Library Director Mimi Hui.

**June 5<sup>th</sup>, Saturday from 9 till Noon** The Borough Sponsored Free Shredding Event took place under the able supervision of Dept. of Public Works Supt. Bill Spindler. I again was happy to bring my box of important papers to be shredded as did Council David Gonzalez.

**June 8th, Tuesday, 7:30 a.m.**, Attended the Bergen County League of Mayors Breakfast at the Arena Diner. Our Special Guest Speaker was Executive Director Bill Dressel of the State League of Municipalities. He gave us a full overview of the Governor's 2.5% CAP along with budget news to date.

**June 9<sup>th</sup>, Wednesday, 10 a.m.**, Met with the Police Arbitrator along with Borough Administrator Michael Kronyak and our Labor Attorney Mark Ruderman for the first time. The Arbitrator also met in another room with the Hasbrouck Heights PBA Representatives.

**2 p.m.** Met with Senator Robert Gordon, along with Borough Administrator Michael Kronyak who presented us with a map of what he and Assemblywoman Connie Wagner would be using as a basis for their plan to divide dissolve the Borough of Teterbor and give parts of it to South Hackensack, Little Ferry, Moonachie and Hasbrouck Heights. I asked him what Teterboro Mayor Watt had to say, and he said he had not met with him yet. I told him we were not happy with what was happening and if and when the Borough was dissolved, Hasbrouck Heights would fight to get the land back that we gave to that Borough in 1918. In answer to one of my questions Sen. Gordon said we would be meeting with the other mayors for further discussion on the matter. We gave him a copy of our 1918 map showing the 1,000 feet East of the Railroad tracks and 7,000 feet from Heights Border on the South going North across Route 46 to the old Ford Plant.

The very next day, I received a call from The Record Reporter saying a consolidation plan was being introduced and wanted to know my thoughts. I gave them as most of you already know.

The story dated Friday, June 11<sup>th</sup> on the front page of The Record had the headline Plan would divvy up a town. Sub heading read Teterboro may be split 4 ways to save money.

I asked Mike Kronyak to contact our Borough Attorney and everyone we needed to prepare to fight this. I called Trenton to ascertain the Bill number and subsequently learned it was A-2939.

I asked Mike to make arrangements for us to meet with Mayor Watt and we have met with him twice since that time.
