

**BOROUGH OF HASBROUCK HEIGHTS**

**MINUTES**

**October 11, 2016**

A Regular Meeting of the Mayor and Council of the Borough of Hasbrouck Heights was held on Tuesday, October 11, 2016 at 8:08 p.m. at Borough Hall, 320 Boulevard, Hasbrouck Heights, NJ.

Mayor DeLorenzo declared the meeting in Session and Borough Clerk Rose Marie Sees stated that the meeting complied with the Sunshine Law, adequate notice of this meeting having been made to all members of the Council by personal service on January 4, 2016 and transmitted to The Observer, The Record and The Herald News on January 4, 2016.

**SALUTE TO THE FLAG AND PLEDGE OF ALLEGIANCE:** Mayor DeLorenzo led in the Salute to the Flag and Pledge of Allegiance.

**INVOCATION:** The Invocation was given by Councilman Traina. He began by saying that yesterday was Columbus Day, and also Mental Health Day. Mayor DeLorenzo requested a motion to approve the foregoing resolution which was made by Councilman Lipari, seconded by Councilman Gonzalez, and unanimously carried.

**PUBLIC HEARING:** Open Space Grant Application – Poured-in-Place Resilient surface - Woodland Park Playground

Mayor DeLorenzo requested a motion to open the Public Hearing which was made by Councilman DiPisa, seconded by Councilwoman Link, and unanimously carried.

CFO/Admin. Michael Kronyak gave a brief summary, noting that every year about this time we put an application to the Bergen County Open Space Trust Fund to improve our parks. Over the last couple of years they changed the application so that we have to advertise the project we are doing and have a public hearing for any public comment on the application. That is what tonight is for. This application is being submitted to install resilient surface at the Woodland Park Playground. We are redoing the park and will put in mulch. The application is in the amount of \$180,000, we're requesting \$70,000 from Open Space with the other \$110,000 to come from the Borough. This is a 50/50 match and only covers the construction portion. We couldn't do this when we did the park due

to limited funds in Open Space. The better way was to split it in two application periods and combine together. If anyone in the public had any questions, he would be happy to answer them. Mayor DeLorenzo asked if anyone had any questions. There being none, the hearing was closed.

Mayor DeLorenzo requested a motion to close the Public Hearing which was made by Councilman Lipari, seconded by Councilman Traina, and unanimously carried.

**MISCELLANEOUS FROM PUBLIC:**

Mayor DeLorenzo requested a motion to open the meeting to the public which was made by Councilman DiPisa, seconded by Councilman Traina, and unanimously carried.

Alex Lovatis and Lois Scheck, 20 Terrace Avenue, residents of the apartment complex for over 20 years, were concerned that the complex was now allowing pets. New neighbors had moved in with a pit bull and they were worried and wanted to avoid any problems. They were advised to contact the apartment complex with their concerns, and it would be checked out to see if the dog was up to date with a license and shots.

There being no one else wishing to speak, Mayor DeLorenzo requested a motion to close the public portion, which was made by Councilman DiPisa, seconded by Councilman Gonzalez, and unanimously carried.

**WORK SESSION:**

Mayor DeLorenzo announced the meeting would continue to the Work Session and requested a motion which was made by Councilman DiPisa, seconded by Councilwoman Link, and unanimously carried.

**ADJOURN:**

There being no further business to be conducted by the Mayor and Council, the meeting was adjourned at 8:47 p.m. on a motion by Councilman Lipari, seconded by Councilman Traina, and unanimously carried.
